Resolution 2021-011

A Resolution Adopting Proposed Redistricting Plans from Sauk County

WHEREAS, in recognition of the constitutional requirements that all elected bodies must reflect the “one person-one vote” concept, and the interrelationship between town, village, city, and county plans of representation, the Wisconsin Legislature has enacted Chapter 4, of the laws of 1981, relating to municipal subdistricting into wards and creation of aldermanic and county supervisory districts; and

WHEREAS, §59.103(b)(2) and §5.15 of Wisconsin State Statutes have been recreated to require that each county board adopt and transmit to each municipal governing body in the county a tentative county supervisory district plan, dividing the county into districts and designating the approximate location and population of each ward proposed to effectuate the division of the county into districts; and

WHEREAS, as amended from time to time, these laws require that each municipality make good faith efforts to accommodate the tentative plan submitted by the county, designating the consecutive number, geographical description and population, and if applicable, the various wards created within the municipality;

NOW THEREFORE, BE IT RESOLVED, the Village Board of the Village of North Freedom has received a copy of the proposed plan and the Board of the Village of North Freedom hereby acknowledges and adopts the following proposed plan:

BE IT FURTHER RESOLVED, that upon passage of this Resolution, the Village Clerk/Treasurer shall transmit a copy to the County Clerk within five (5) days of its adoption and that this Resolution shall remain in effect for each election until modified or rescinded, in accordance with Wisconsin State Statute, or until a new division is made following the next federal decennial census.

This resolution was adopted at the Village of North Freedom Regular Board meeting on October 11, 2021 on a motion presented by Trustee Weiland and seconded by Trustee Carignan.



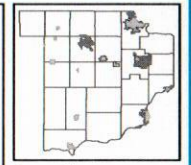

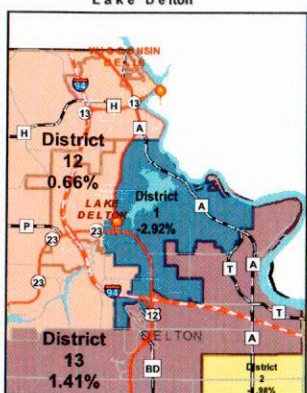

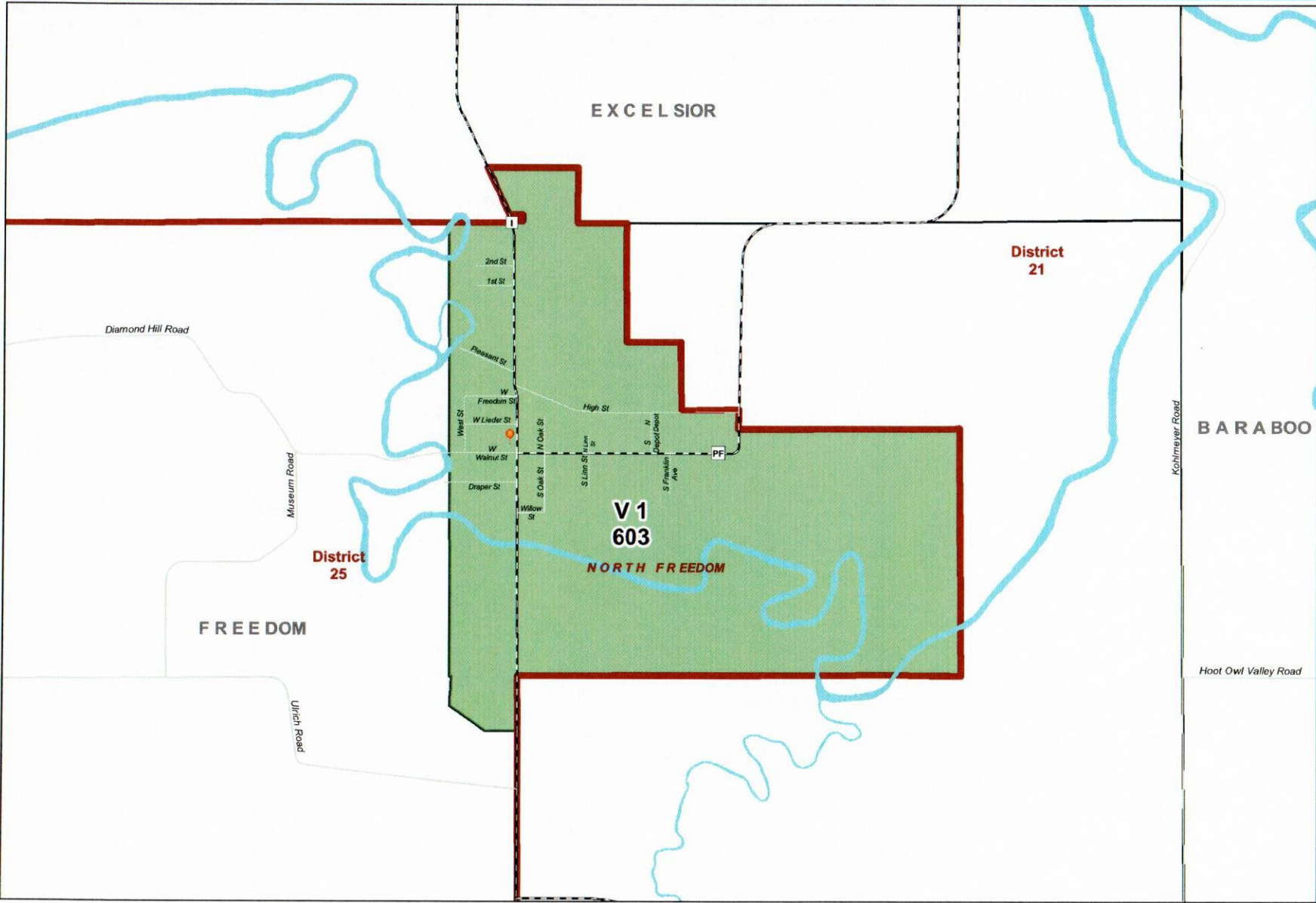
